



FAQs

When exploring Club membership there are often questions. To help welcome and inform you, we have created a list of FAQs and answers to help understand how The Amelia Island Club functions.

1. How many members belong to The Amelia Island Club?

Approximately 1180 families are on the Amelia Island Club roster.

2. Is residency in Amelia Island Plantation a requirement to become a member?

No, one can live anywhere and be eligible to apply for Club membership

3. What is the difference in the Membership Classifications?

4. Who can use my membership, and can it be transferred and inherited by a family member?

Memberships include the Extended Family, which represents collectively, grandparents, parents, adult children and grandchildren of an Equity Member or his or her Spouse, and their respective Spouses. Memberships may be transferred to an adult child or adult grandchild or inherited by an adult child or adult grandchild without the payment of any additional Membership Contribution.

5. As a member am I able to invite guests?

Having your friends enjoy the Club's facilities with you is a wonderful attribute of membership. Therefore, members are encouraged to invite guests to the Club subject to rules and regulations adopted by the Club.

6. What kind of operations and services can I expect at The Amelia Island Club?

Our Club's facilities and services exceed the quality of any area club. A complete range of first-class events and activities are offered on a year-round basis. The monthly Club calendar will list specific functions and offerings with special events, golf, tennis, swimming, and dining, and will be detailed on the Club website. Recognizing the active lifestyles of our members, we offer full menu service for social functions, along with member catering options. Member activities will focus on fostering friendships among a broad base of the membership.

7. How do you help new Members make friends?

In addition to the many social functions, we host many special events and new Member Cocktail Receptions. Our Club Ambassadors are also very active introducing themselves and other Members to our new Members, so they feel welcome and part of the Club immediately.

8. Is AIC an equity club? What is an equity club?

Yes, we are an equity club. In a member owned or equity club, each equity member has an ownership interest in the club, this type of club permits its equity members to control their club through the right to vote. The club facilities are managed and operated under the direction of a Board of Directors ultimately elected by the equity members.

9. Why should I join The Amelia Island Club versus other private Clubs in the area?
